President's Message

It's that time of year again when we look back to consider our successes and look forward to our challenges for the New Year. The branch continues to enlist new members, fund student grants, Tech Trek campers and the AAUW Fund, and also to enjoy the friendship within our many social groups while furthering **AAUW's mission to advance equity for women and girls through advocacy, education, philanthropy, and research**. This is also the future challenge.

Part of **our** challenge is to become informed of the many funds under the big umbrella, the AAUW Fund... One of these funds is the Legal Advocacy Fund (LAF), which supports plaintiffs who fight gender discrimination and harassment in the workplace and in education. Since 1981, LAF has given more than \$1.4 million to support more than 100 cases across the country.

One of the cases is Rizo v. Fresno County Office of Education. Rizo is a math consultant for the Fresno County Office of Education in Fresno, California. She filed suit against the County under equal pay and gender discrimination laws after discovering she was paid less than her male colleague who had less experience and seniority. Rizo challenged the County's practice of basing pay exclusively on an employee's prior salary history. (The recent Equal Pay Law has changed this but it is not retroactive.) The case was filed in 2014 and Rizo is awaiting the court's ruling on the summary judgment before moving toward trial.

As the year comes to an end, a big **THANKS** to all the Branch officers and members who made this year a success!!

Los Angeles County Interbranch Council (LACIC) this month hosted Raphael Sonenshein, Ph.D., speaking on *LA County and Its Elections*. Dr. Sonenshein is Executive Director of the Pat Brown Institute of Public Affairs at CSU Los Angeles Dr. Sonenshein commented on the influence of Latino and migrant voters and their growing influence in the politics of the county. In the 1990's one million new Latino voters were registered and mostly as democrats. This turned California into a Democratic stronghold. A suit was filed in 1991 to force the establishment of a Latino district in the county supervisors. His primary point is, "... the rise of Latino and Asian communities will reshape Los Angeles County and the state."
