YOUR AAUW FUND DONATIONS AT WORK!

Recently, I received the following letter from one of our California grant recipients who attended our branch meeting. She was enrolled in a Masters Program at Cal State Northridge in Deaf Education. She, herself, was deaf and was interested in the field of cochlear implants as a hearing loss solution. So many wonderful women benefit from our donations to AAUW Funds.

Dear Glendale Branch,

I am not sure if you remember me, but I came to one of your AAUW meetings a couple years back. I was a recipient of the AAUW Career Development Grant, and I believe your branch was responsible for a big portion of the funding I received to help pay for my Master's degree.

I wanted to share some good news that came as a direct result of me obtaining my M.S. I was selected as a Presidential Management Fellows (PMF) finalist earlier this year. The PMF Program is administered by the U.S. Office of Personnel Management each year and is designed to groom future government leaders. It's a highly selective program and a great opportunity! For the 2017 class, there were over 6300 applicants and only 417 were selected as finalists. Only about 50-60% of those finalists actually get appointed to fellowship positions. I am thrilled to say that I was selected as a finalist, and after months of applying for various positions, was finally appointed to a fellowship position at the National Institutes of Health (NIH). I am moving to D.C. next month!

I wanted to share this news with someone at AAUW, because I am so incredibly thankful for the grant that I received. I was not sure who else to contact! The grant helped me so much...and because I was able to graduate, I now have this wonderful opportunity awaiting me. I will be forever grateful to AAUW.
