The New Aging with Dr. Torres-Gil

A dear friend, former professor, and mentor of AAUW-member Camille Veneracion. Fernando M. Torres-Gil's multifaceted career spans the academic, professional, and policy arenas. He is a Professor of Social Welfare and Public Policy at UCLA, an Adjunct Professor of Gerontology at USC, and Director of the UCLA Center for Policy Research on Aging.

He earned his first presidential appointment in 1978 when President Jimmy Carter appointed him to the Federal Council on Aging and appointed (with Senate Confirmation) by President Bill Clinton as the first-ever U.S. Assistant Secretary on Aging in the U.S. Department of Health and Human Services (DHHS). As the Clinton Administration's chief advocate on aging, Torres-Gil played a key role in promoting the importance of the issues of aging, long-term care and disability, community services for the elderly, and baby boomer preparation for retirement.

1st-National Mentoring Month

January is National Mentoring Month, and full of inspiring words of wisdom, thoughtful counseling, and meaningful mentor-mentee relationships.

1st-National Stalking Awareness Month

The Violence Against Women Act reauthorization updated the Clery Act, and the U.S. Department of Education took the next step in the process of finalizing the new regulations. The regulations will

clarify the updated law, which requires schools to make their campus disciplinary processes more transparent, to train and educate students as well as faculty and staff, and to update sexual assault policies. The updates to the Clery Act also call for gathering new statistics, starting this year, about domestic violence, dating violence, and stalking.

1st-Slavery and Human Trafficking Prevention Month

Between 1861 and 1865, the United States fought a brutal war that divided the nation. By the war's conclusion, the Union had been preserved and slavery officially ended. Yet more than 150 years later, the nation is still fighting slavery, albeit in a different form: human trafficking. AAUW strongly supports efforts to combat trafficking, a position formally adopted as part of our public policy agenda by AAUW members in 2011.

29th-Lilly Ledbetter Act signed into law

Lilly Ledbetter is the woman for whom the bill is named and perhaps the best-known face of pay equity. For nearly two decades at the Goodyear Tire & Rubber Company in Gadsden, Alabama, Ledbetter worked for less money than male co-workers with the same job. She lost more than \$200,000 in salary, benefits, and retirement savings due to pay discrimination. After her November 1998 retirement, she filed suit under Title VII of the Civil Rights Act of 1964 and was awarded back pay and other remedies in a jury trial. The U.S. Supreme Court's 5-4 decision not only erased Ledbetter's award, but also left women, minorities, and others in Ledbetter's situation with virtually no recourse to pay discrimination. http:// www.aauw.org/2009/01/29/lilly-ledbetter-fair-pay-actsigned-into-law/
