Hello Glendale Branch:

On the 27th of October, four of us attended the annual Funds Luncheon in Seal Beach. Anna Hernandez-Torres drove Hannah Cline, Birdie Zitnick (my Mom), and myself. I think it is essential for new members to be able to experience the Funds Luncheon at least once in their membership with AAUW, which is why I insisted that my Mother come this year. There were twelve young ladies who were recipients of our American Fellowships and five young ladies who were recipients of our International Fellowships. We had nine young ladies who were recipients of our Selected Professions Fellowships, and twelve young ladies who were recipients of our Career Development Grants. A couple from each category came up and talked about what she is working on and thanked AAUW for the ability to continue due to the funds that we provide. We also gave out two Community Action Grants this year; one to Cher Martin from the Girl Scouts of Redlands, and one to a Georgia Van Cuylenburg who created her own Non-Profit (Arts Bridging the Gap, LA-“Girls Make VR”) to help traumatized children through art.

We were given some facts about AAUW this year that I thought I would pass on to the Glendale membership. By August 31, 2019, our Work Smart program has trained 102.7k women in salary negotiation. This accomplishment was made possible by us due to the generous grant from the Coca Cola Corporation. AAUW has sought out large corporations to donate so that we can turn around and grant monies to students, Start Smart, Work Smart, NCLWSL, and Tech Trek. Due to some very generous donations, AAUW has many Fellowship and Grant monies, which is why we were able to help out more young women this year than in past years. We were encouraged to get our new members, of working age, to go on the internet and take the Work Smart course. We were told that women across the country are finding locations where the program is being taught and attending classes closest to them. AAUW’s new pilot program, the Equity Network, is tied in to our Work Smart and Start Smart programs.

That is why we are now encouraged to donate to our “Greatest Needs” fund to help support these programs. National AAUW will announce the Grant Match program from the “Greatest Needs” program will be on December 3, 2019.

Previously, I wrote to you about our new 5 Star Program. AAUW has created a website for everyone to keep up on the latest on each branch and to post how your branch is

accomplishing its goals. If you would like to check it out, go to www.aauw/5star.org. We were told that there is a quote on there from Billie Jean King, “Champions keep playing until they get it right!” We were also told that Giving Tuesday is the Tuesday after Thanksgiving, and we were encouraged to remember to donate to AAUW. Due to the fabulous technology we now possess, we can listen and watch shows on our phones. 
